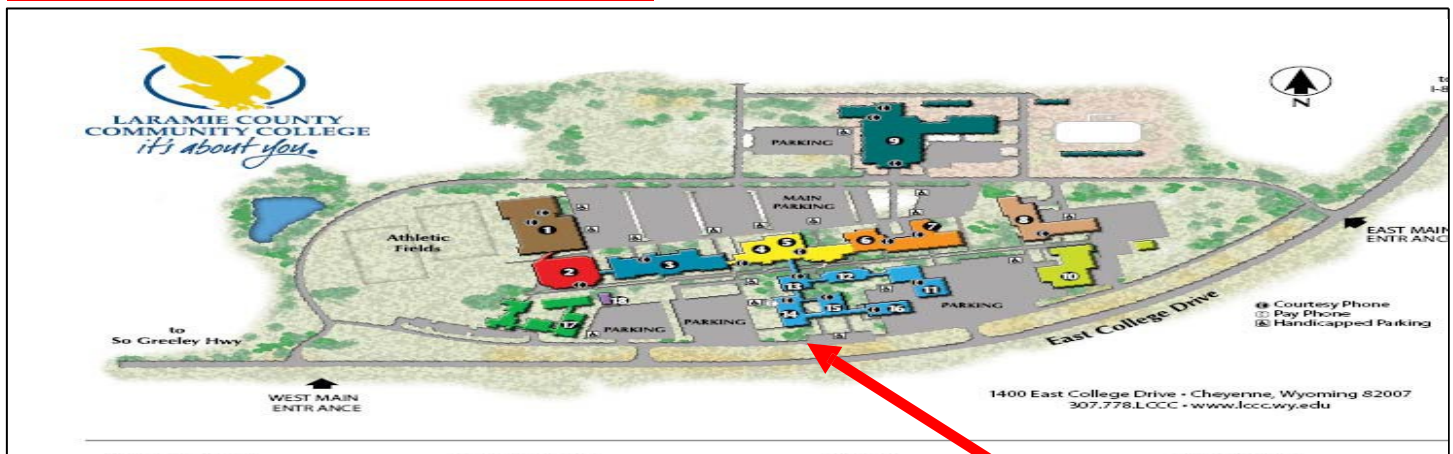

DEDUCTIBLE EXPENSES: MORTGAGE INTEREST PAID; RECEIPTS FOR PROPERTY TAXES, MEDICAL EXPENSES, CHARITABLE CONTRIBUTIONS, ETC.
